TO THE HONORABLE J.D. LEIGH, JUDGE OF THE CIRCUIT COURT, BALDWIN COUNTY, ALABAMA, -----IN EQUITY.

Your Oratrix, Lula Devine, respectfully represents and shows unto Your Honor as follows:

First.

That she is a bona fide resident citizen of Baldwin County, Alabama, and is over the age of twenty-one years

That Robert Devine, is a resident of Baldwin County, Alabama, and is over the age of twenty-one years of age.

That both Your Oratrix, Lula Devine, and the said Robert Devine are residing at Loxley, Alabama, Baldwin County.

SECOND.

That your Oratrix and the said Robert Devine were lawfully married about six months ago, and that they are now man and wife.

THIRD.

That your Oratrix and the said Robert Devine lived together for about four days, and that during that time, the said Robert Devine so cruelly treated your Oratrix as to make life unbearable, that he struck her with his hand and thereby rendered it dangerous to her life or health and that the said Robert Devine does not treat your Oratrix as his wife, and from his conduct towards your Oratrix, there is reasonable apprehension that he will again mistreat your Oratrix, thereby endangering har life or health.

Prayer for Process.

The premises considered, Oratrix prayes that the said Robert Devine be made a party to this bill of complaint by the usual Process of this honorable court, and that he be required to demur, plead to or answer the same within the time and under the penalties as provided by law, or that the same be forever confessed, and all other orders and decrees that may be necessary to obtain the relief prayed.

Prayer for Relief.

That upon the final hearing of this cause, your Honor will grant unto Oratrix an absolute divorce from the said Robert Devine, and that she be again allowed to contract marriage; that if your Oratrix be mistanen in the relief prayed, that Your Honor will grant unto her such other, futher, different and general relief as she may in justice and equity be entitled, she will ever pray, etc.
