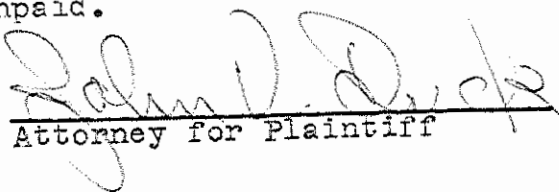
BILL OF COMPLAINT

COUNT ONE

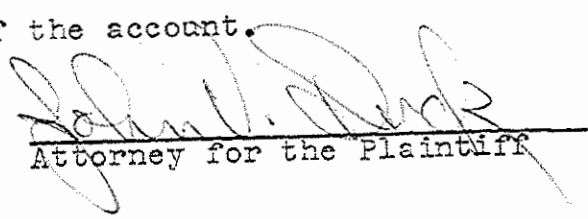
