Comes the Defendant in the above styled cause and demurs to the complaint filed in said cause and each and every count thereof, severally and separately, and assigns the following separate and several grounds, viz:

- 1. That said complaint does not state a cause of action.
- 2. That no facts are alleged in the complaint to show that the Plaintiff is entitled to the money sued for.
- 3. For aught that appears from said complaint the Plaintiff is not the sole heir at law and next of kin of Ellen Virginia Horton.
- 4. That the allegation in count "l" that the money was wrongfully paid is but a conclusion of the pleader.
- 5. That count "l" of the complaint fails to allege when the money was paid to the Defendant.
- 6. That count "1" of said complaint fails to allege sufficient facts in connection with the money being paid to the Defendant.
- 7. That said complaint fails to allege whether the father of Ellen Virginia Horton is living or dead.
- 8. That the allegation in count "2" of the complaint that the money paid to the Defendant is the property of the Plaintiff is but a conclusion of the pleader and does not state sufficient facts to show that she is the owner of such money.
- 9. That count "2" of the complaint does not allege that the Defendant was a party to the conversion of the money.
- 10. That said complaint affirmatively shows that if the Plaintiff has a cause of action against anyone, that such cause of action is against Royal Indemnity Company and not the Defendant.
