COUNT ONE:

The Plaintiff claims of the Defendant the sum of One Hundred Seventy-four and 50/100 Dollars (\$174.50), the balance due under a contract made and entered into by and between the Plaintiff and the Defendant on July 22, 1957, under the terms of which the Defendant was to pay to the Plaintiff the sum of Seventeen and 45/100 Dollars (\$17.45) each month, commencing August 15, 1957, for eighteen consecutive months. Plaintiff avers that the Defendant has made eight payments in the amount of \$17.45 each, the last of which payments was made on March 24, 1958, and that the balance of the said payments are now due and payable.

Plaintiff further avers that under and by the terms of the said contract, the Defendant agreed to pay fifteen percent (15%) of the amount due as attorney's fees in the event the said contract was placed in the hands of an attorney for collection, and Plaintiff


avers that it has become necessary to place the said contract in the hands of an attorney for collection and claims an attorney's fee of Twenty-six and 17/100 Dollars (\$26.17).
