Flowers, the plaintiff's left hip was bruised, contused, sprained and injured; his left wrist was bruised, contused, sprained and injured; his back was bruised, contused, sprained and injured; his chest was bruised, contused, sprained and injured; his nervous system was shocked and impaired; his nervous system was permanently shocked and impaired; and he was caused to suffer great physical pain and mental anguish, and also caused to expend large amounts for treatment of his said injuries.

The plaintiff claims of the defendants, Loren E. 


