Come now the defendants Wilson Bruton and Howard Pearson and demur to the plaintiff's complaint and to each count thereof, and as grounds for said demurrer set down and assign the following separately and severally:

- 1. Said count fails to allege the violation of any duty owed by these defendants to the plaintiff.
- 2. Said count fails to allege facts showing the violation of any duty owed by these defendants to the plaintiff.
- 3. For aught that appears from said count, the accident did not occur on a public street.
- 4. For aught that appears from said count, the plaintiff was not at a place where he had a legal right to be at the time and place complained of.
- 5. For aught that appears from said count, the injuries and damages suffered by the plaintiff were not the proximate result of any act or failure to act on the part of these defendants.
- 6. For that said count fails to allege any casual connection between the alleged negligence of these defendants and the alleged injuries and damages of the plaintiff.
- 7. For that said count attempts to allege the negligence of these defendants but does not allege facts which as a matter of law constituted negligence.
- 8. For that the allegations thereof are so vague and indefinite that these defendants are not advised thereby of the matters and things to be defended.

- 9. For that no facts are alleged to show joint liability on the part of the defendants.
- 10. For that no facts are alleged to show any individual liability on the part of these defendants.
- 11. For that said count fails to allege facts to show negligence with sufficient certainty against either defendant.
 - 12. For that there is a misjoinder of causes of action.
 - 13. For that there is a misjoinder of parties.
- 14. For that the said complaint attempts to proceed against both defendants in the same counts, separately and severally.
- 15. For that the plaintiff seeks to hold the defendants liable for trespass and case, in the same count.
