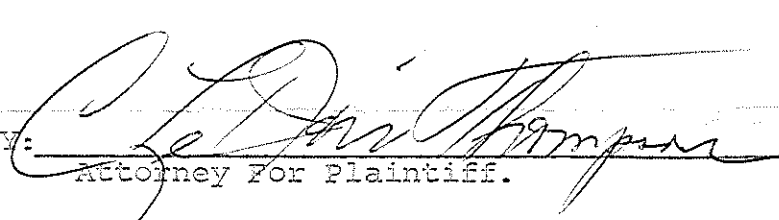
The Plaintiff claims of the Defendants Three Hundred Thirty-
