

STATEMENT AND PETITION

The undersigned being the only parties interested in this matter, hereby petition the Court for approval of the following agreement and settlement and agree and represent unto the Court as follows:

- l. The said employee, Lawrence W. Egebrecht, (sometimes known as Larry Egebretch) and the said employer, Baldwin County Electric Membership Corporation, are now and were at the time of the injury to the employee, which is hereinafter described, subject to the provisions of the Workmen's Compensation Law of Alabama. The undersigned Employers Mutual Liability Insurance Company of Wisconsin, a corporation, (sometimes described as Employers Mutuals of Wausaw) was the insurance carrier for the said employer at the time of the accident.
- 2. The said employee, who is over the age of twenty-one and who resides in Baldwin County, Alabama, who can read and understand the English language, did, on the 4th day of June, 1958, sustain an injury by accident while working for the said employer in Baldwin County, Alabama, by lifting a pole to be placed upon a trailer hitch, and such resulted in permanent partial disability to said employee, which has been fixed by his doctors at five (5%) percent, which figure has been adopted for the purpose of this settlement.
- 3. The said employee received at the time of his injury wages of Forty-five (\$45.00) Dollars per week.
- 4. The total compensation to which the said employee is entitled for an injury resulting in a five (5%) percent partial disability (Title 26, Section 279, Subsection C,

1949 Code of Alabama, as amended) is Four hundred and thirty-eight(\$438.00)Dollars.

- 5. The said employer, through his insurance carrier, has paid to the said employee compensation in excess of \$800.00, said payments being made to the employee since his injury. The employee acknowledges that he will be paid in this settlement, an additional \$200.00, which total sum paid in this settlement and those sums paid as compensation since his injury will greatly exceed the full amount of compensation that he is, and was, entitled to receive from the said employer and its insurance carrier, and upon receipt of this additional \$200.00, the said employee agrees to give the said employer and his insurance carrier, a proper receipt and release.
- 6. The employee acknowledges that he has received to date all medical and surgical treatments and benefits given and provided by the Workmen's Compensation Act of Alabama, and to which he is entitled by virtue thereof.
- 7. The settlement as set out herein contains the whole agreement between the parties hereto.
