The petition of Jessie Greer, who is over the age of 21 years and

shows and represents unto your Honor:

FIRST.

That he is now illegally restrained of his liberty and is
imprisoned in the county jail of Baldwin County, Alabama, at Bay
Minette, in said County, by Taylor Wilkins, the Sheriff of said County,
the said Taylor Wilkins, as Sheriff of said County restrains your
petitioner under a commitment issued on February 2nd by W. R. Stuart
as Judge of the County Court of Baldwin County on an excessive
sentence of 6 months in the county jail and a fine of \$500.00 for a
charge of VPL, in said court, and that your petitioner has announced
his appeal in said cause and that ~~the said W. R. Stuart~~, Judge of
the County Court of Baldwin County orally set excessive bond, to-wit,
\$1,000.00 pending appeal; but that the said W. R. Stuart Judge of
the said County Court of Baldwin County has failed or refused to

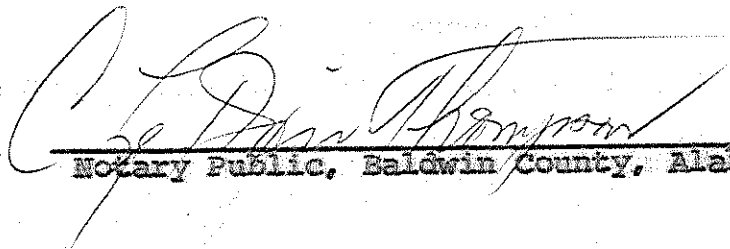

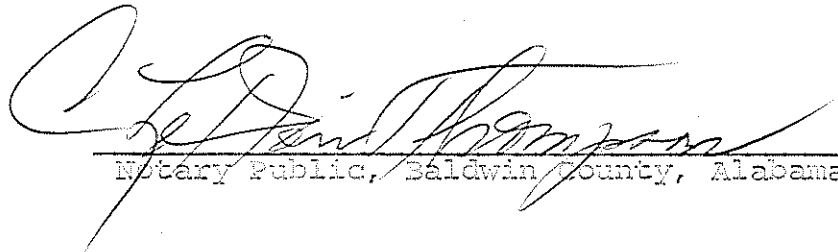
