Plaintiff claims of Defendants TWO HUMDRED FIFTY DOLLARS (\$250.00) for that heretofore, on, to-wit, July 1, 1959, Plaintiff was traveling in her automobile in a Southerly direction along the Brady Road Extension in Baldwin County, Alabama, where she had a right to be, and at a point approximately 100 feet South of where the pavement ends on the said Brady Road Extension, and while Plaintiff was so traveling in her automobile, which she was driving at said time and place, a truck belonging to Defendant, City Furniture Company, which was then and there being driven by Riley Sanspree, who was, at said time and place, an agent, servant or employee of the said Defendant, City Furniture Company, acting

within the line and scope of his authority as such agent, servant or employee, which said truck was being driven in a Southerly direction along the said Brady Road Extension, attempted to pass the automobile of the Plaintiff, and in so doing the said truck was so negligently operated by the said agent, servant or employee of the Defendant, City Furniture Company, who was then and there acting within the line and scope of his authority as such agent, servant or employee as to cause it to strike, run upon, over or against the automobile of the Plaintiff and as a proximate consequence of the Defendant, Riley Sanspree's, negligence, who was then and there an agent, servant or employee of the Defendant, City Furniture Company, a partnership composed of Norman A.
