The Plaintiff claims of the defendant THREE HUNDRED FIFTY-NINE and 57/100 DOLLARS (\$359.57), balance due on a promissory note made by the defendant on the 16th day of July, 1956 and payable in fifteen monthly installments, one installment being due and payable on October 15, 1956. The Plaintiff avers that the defendant defaulted in the payment of this installment and all subsequent monthly installments and that the whole balance has become due and payable. The Plaintiff claims interest at the rate of 6% per annum from the 15th day of October, 1956; this being provided for in the terms of said promissory note. The Plaintiff further avers that the defendant agreed in said promissory note to pay all expenses including reasonable attorney's fees incurred in collecting the same and the Plaintiff claims a reasonable attorney's fee in the amount of FIFTY-FIVE DOLLARS (\$55.00).
