One note for \$46.25, dated November 10, 1928, payable 180 days after date -

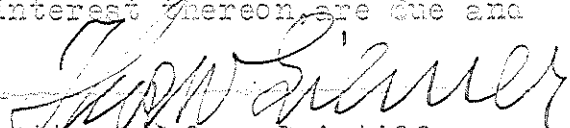
One note for \$56.20, dated August 5, 1929, payable 30 days after date -
