KNOW ALL MEN BY THESE PRESENTS: That the Baldwin County Bank, a corporation, as Principal, and the undersigned, as sureties, are held and firmly bound unto R. A. Smith and Sue B. Smith in the sum of One Thousand Dollars (\$1,000.00), for the payment of which well and truly to be made, we, jointly and severally, bind ourselves and each of us, our successors and assigns, heirs, executors and administrators, firmly by these presents.

THE CONDITION OF THE ABOVE OBLIGATION IS SUCH: That Whereas, the said Baldwin County Bank, a corporation, did, on the 27th day of November, 1931, sue out of the Circuit Court of Baldwin County, Alabama, a Writ in Detinue directed to any Sheriff of the State of Alabama, commanding him to take into his possession the following property, to-wit:

Twenty-four (24) head of oxen, being all the oxen owned by R. A. Smith and Sue B. Smith on the 26 day of August, 1926; also Two (2) log carts, Two (2) eight-wheel hemming log carts; also all yokes, bows, chains and other equipment used in connection with said teams;

which said Writ was placed in the hands of W. R. Stuart, Sheriff of Baldwin County, Alabama, on the 27th day of November, 1931, and executed by him on the 28th day of November, 1931, by taking into his possession the following property, to-wit:


Ten (10) head of oxen; Two (2) log carts and Two (2) eight-wheel hemming log carts, and all equipment used in connection with said team;

And Whereas, the said R. A. Smith and Sue B. Smith, the

Defendants in said Writ, have failed and neglected, for the space of five days from the execution of said Writ, to give Bond and take possession of said property as authorized by law;

Now, if the said Baldwin County Bank, a corporation, upon its failing in said suit, shall deliver the said property to the Defendants within thirty days after Judgment and pay damages for the detention of the property and costs of suit, then this obligation to be void, otherwise to remain in full force and effect.
