

COMPLAINT

COUNT ONE

The Plaintiff claims of the Defendant THREE HUNDRED AND THIRTY AND NO/100 (\$330.00) DOLLARS, the rent of a tract of land, viz: Dwelling located at 152 Gaston Avenue, Fairhope, Alabama, demized by the Plaintiff to the Defendant on to-wit the sixth day of March, 1959, said rent commencing on the sixth day of March, 1959, and ending on the fifth day of March, 1960.

COUNT TWO

The Plaintiff claims of the Defendant the sum of THREE HUNDRED AND THIRTY AND NO/100 (\$330.00) DOLLARS due by Realestate lease made by the Defendant on to-wit the sixth day of March, 1959, and payable in monthly installments of SIXTY (\$60.00) DOLLARS each due and payable respectively on the sixth day of March, 1959, and on the sixth day of each month thereafter for eleven months and said lease contains a provision that if the defendant fails to pay the rents as they fall due, the rents for the whole term shall at once become due and payable and the Defendant failed to pay \$30.00 rent of the \$60.00 which fell due on the sixth day of October, 1959, and all rents thereafter.

COUNT THREE

The Plaintiff claims of the Defendant the sum of SIXTY-SIX AND NO/100 DOLLARS (\$66.00) as a reasonable attorney fee which is provided for in said lease for the collection of this debt and shows to the Court that the Defendant waived as to the debt sued

for his right of exemption as to personal property granted under the Constitution and Laws of the State of Alabama which waiver the Plaintiff now claims.
