WHEREAS, on September 23rd, 1930 the Circuit Court of Baldwin County, Alabama, did render a Judgment in favor of Robertsedale Hardware Company, a co-partnership composed of James T. Haden and Charles L. Matthews, as Plaintiffs, and against Angus Merchant and J. E. Newberry, as Defendants, in the sum of One Hundred Seventeen & 68/100 Dollars (\$117.68) debt and Fifteen & 95/100 Dollars (\$15.95) Court costs;

AND WHEREAS, the said James T. Haden has made Affidavit as required by law, setting forth that said Judgment was rendered, the parties thereto, the amount due, and that Process of Garnishment is believed to be necessary to obtain satisfaction of said judgment.

THESE ARE THEREFORE TO COMMAND YOU, that you summon the Consolidated Indemnity & Insurance Company, a Corporation, to be and appear before the Circuit Court of Baldwin County, Alabama, to be held for said County within thirty days from the service of this Writ, then and there to answer upon oath whether at the time of the service of the Garnishment, or at the time of making its answer, or at anytime intervening between the time of serving the Garnishment and making its answer, it was indebted to the Defendant, J. E. Newberry, and whether it will be indebted in the future to said Defendant by a Contract then existing, and whether by a contract then existing it will be liable to the said Defendant J. E. Newberry for the delivery of personal property, or for the payment of money which may be discharged by the delivery of personal property, or which is payable in personal property, and whether it has not in its possession, or under its control,

Matthews, and as such is duly authorized to make this Affidavit; that the said Robertsdale Hardware Company, a Co-partnership, as Plaintiff, recovered a Judgment on the 23rd day of September, 1930, against Angus Merchant, as Defendant, and J.
