



1- Edward P. Totten, Fairhope, Alabama.

2- On January 28th, 1932, a certificate for ten shares of capital stock of the Orange Beach Land Company, of Robertsdale, Alabama, being certificate left with me by R. C. Keeney, of Fairhope, was in possession of Mrs. Esther L. Gordon, of New York City, N. Y.

3- On December 11, 1931, I had in my care a certain certificate, numbered 16, for ten shares of capital stock of the Orange Beach Land Company, of Robertsdale, Alabama, which was in the possession of Mrs. Esther L. Gordon, of New York City, N. Y.

4- On December 11, 1931, I had in my custody, as attorney for Mrs. Esther L. Gordon, of New York City, N. Y., a certain certificate, Numbered 16, for ten shares of capital stock of the Orange Beach Land Company, of Robertsdale, Alabama, but the possession of the said certificate was with my client, Mrs. Gordon.




