Plaintiff avers that in and by the terms of the notes hereinabove sued upon, the Defendant waived all right to claim

personal property as exempt from execution and sale or other process issued for the collection of same, and agreed to pay all cost of collecting, securing or attempting to collect or secure said note, including a reasonable attorney's fee, which Plaintiff claims, to-wit, \$50.00.
