COUNT ONE

Plaintiff claims of Defendant the sum of FOUR HUNDRED SEVENTY AND 00/100 (\$470.00) DOLLARS, due by promissory note made by him on, to-wit, June 30, 1959, which provided for payment by consecutive monthly installments of THIRTY AND 00/100 (\$30.00) DOLLARS each and one final installment of TWENTY AND 00/100 (\$20.00) DOLLARS, to commence on, to-wit, July 30, 1959. Said note further provides that upon failure to pay any installment when due, the entire sum shall, at the option of the holder, become due and payable. Plaintiff avers that it has exercised its option and declared the entire sum due and payable, the Defendant having defaulted in the payment due in, to-wit, July 1959 and all subsequent payments. Plaintiff further avers that in said note Defendant did agree to pay, as a delinquent penalty, a fine of two (2) cents on each unpaid dollar per month while delinquent, and Plaintiff claims further the sum of ONE HUNDRED AND OO/100 (\$100.00) DOLLARS, as the total of such fine. Defendant further agreed to pay a reasonable attorney's fee which might ensue as a cost of collection upon default of Defendant, and Plaintiff claims the sum of ONE HUNDRED THIRTY ONE AND 60/100 (\$131.60) DOLLARS, as a reasonable attorney's fee.

Plaintiff further avers that in said note Defendant did waive all right in and to his exemption of personal

property under the Constitution and laws of the State of Alabama and Plaintiff claims the benefit of such waiver.

WHEREFORE, Plaintiff claims of Defendant the sums hereinabove set out, with interest thereon.
