COUNT I



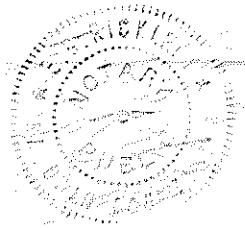
