The diagram illustrates the reaction of 2-mercaptoethanol ($\text{HS-CH}_2\text{-CH}_2\text{-OH}$) with a disulfide bond (S-S). The reaction proceeds via a nucleophilic attack of the thiol group on one sulfur atom, leading to the formation of a mixed disulfide intermediate ($\text{HS-CH}_2\text{-CH}_2\text{-O-S-S-}$) and the release of a thiolate ion (S^-). This process repeats until all disulfide bonds are reduced to free thiols.
