and willing and offered to defendant to pay twelve-hundred (\$1,200.00)
dollars and duly to perform all of his obligations under said agreement, on like performance by Defendant.

Plaintiff further alleges that the Defendant breached the said agreement in that title to the property was not free of all encumbrances in accordance with the agreement as herein attached, that the agreement states "If title is bad ernest money is to be refunded". That Plaintiff has demanded and requested a refund of the said three-hundred (\$300.00) dollars in accordance with the agreement entered into by the parties, and the Defendant failed and

and refused to return the same.
