COUNT III:

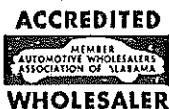

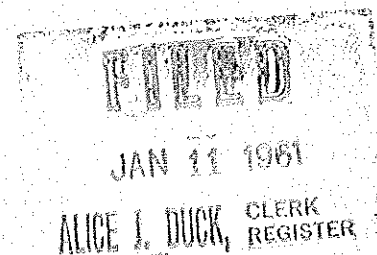
