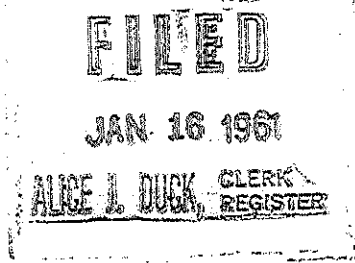
COUNT THREE:

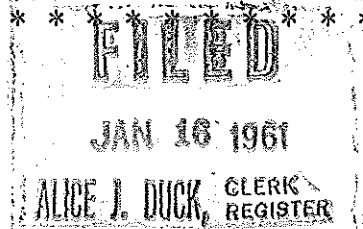
