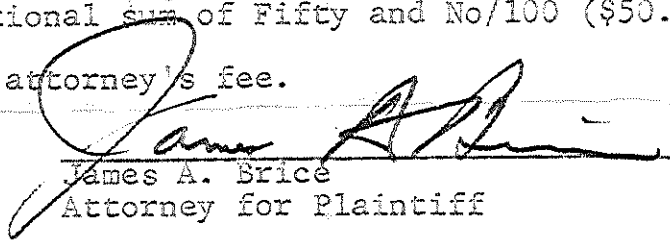

The plaintiff claims of the defendant the sum of Two Hundred Seventy-one and 70/100 (\$271.70) Dollars, due by promissory note made by the defendant on the 25th day of June, 1954, and payable on 15th day of October, 1954, with interest from 11th day of December, 1956, at the rate of six (6%) per cent per annum.

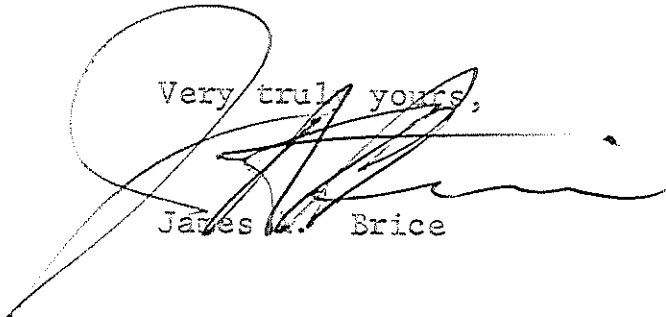
