The plaintiff claims of the defendnat the sum of One Thousand Three Hundred Seventy-nine and 06/100 (\$1,379.06) Dollars, due by promissory note made by the defendant on the 29th day of November, 1955, and payable on June 1, 1956, with interest from June 1, 1956, at the rate of six (6%) per cent per annum.

Plaintiff avers that in and by the terms of said note the defendant waived all right to exemption under the constitution and laws of the State of Alabama, and of this waiver plaintiff now claims benefit.
