ORDER FIXING VALUE OF APPELLANT'S PROPERTY ON
 APPEAL FROM ASSESSMENT MADE BY BALDWIN COUNTY
 BOARD OF EQUALIZATION.

This cause coming on to be heard on this date, being the date heretofore set for hearing this appeal, and the appellant being represented by her attorney and the appellee by the Solicitor of the Twenty-eighth Judicial Circuit, and it being made to appear to the Court that the property of the appellant is assessed for taxation for the year of 1960 in Beat or Precinct 2, Assessment No. 56, as follows:

The lands described in the said assessment at the total sum of \$17,040.00;

Personal property, \$140.00, making a total assessment of \$17,180.00;

that the Baldwin County Board of Equalization did on, to-wit, June 24, 1960, fix the valuation on the lands described in the said assessment as follows:

The lands described in the said assessment at the total sum of \$20,560.00, personal property at \$140.00, making a grand total of \$20,700.00;

That the appellant did prosecute an appeal to this Court under the relevant statutes of the State of Alabama (Title 51, Sections 109-113, 1940 Code of Alabama), upon which appeal it is necessary that this Court fix the valuation of the property described in the said assessment for the tax year of 1960; and the appellant and the State, acting through their attorneys, have agreed to the valuations set out below and that this Court fix the valuations so agreed upon:

It is, therefore, ORDERED AND ADJUDGED that the valuations of the property of the appellant for the tax year of 1960 be and the same are hereby fixed as follows:

1450 acres of land at \$6.00 per acre, assessed valuation	\$ 8,700.00
864 acres of land at \$8.00 per acre, assessed valuation	6,910.00
Personal property	<u>140.00</u>
Total assessed valuation	\$ 15,750.00

The Clerk of this Court is hereby directed to promptly furnish a copy of this order to E. S. Tunstall, Tax Assessor of Baldwin County, Alabama. E. S. Tunstall, as said Tax Assessor, is hereby directed to compute the amount of taxes due by the appellant taxpayer on the said assessed valuation of \$15,750.00, as set out above, and furnish this information to the Tax Collector of Baldwin County, Alabama, who shall furnish to the appellant taxpayer as soon as possible a statement showing the amount of taxes due on the said assessment for the tax year of 1960.

The court costs incurred in this appeal are hereby taxed against the appellant, for which execution may issue.
