

COMPLAINT

The Plaintiff sues to recover possession of the following tract of land situated in Baldwin County, Alabama, to-wit:

Beginning at the Northeast corner of Section 24, Township 8 South, Range 3 East and run West 5 degrees South 10 chains to a point; run thence South 5 Degrees East 10 chains to a point; run thence East 5 degrees North 10 chains to a point; run thence North 5 degrees West 10 chains to the point or place of beginning, excepting therefrom the following:


