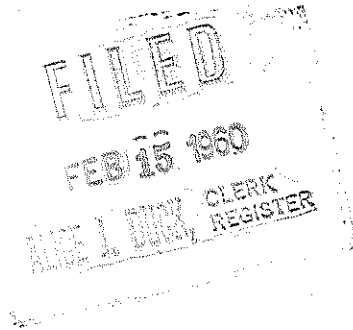
COUNT I


The Plaintiff claims of the Defendant Six Hundred Dollars (\$600.00) due by Promissory Waive Note made by him on, to-wit, June 1, 1957, payable one year after date, plus interest at the rate of six per cent (6%) per annum from June 1, 1959.



