The Plaintiff claims of the Defendant the sum of \$139.18 due by promissory note made by her on the 9th day of June, 1959, and payable in twelve (12) monthly installments of \$11.59 each exempting the final installment of \$11.69, the first payment being due on the 15th day of July, 1959, with interest thereon at the rate of eight (8) per cent per annum from date.

Plaintiff alleges that in and by the terms of said note, the Defendant waived as to this debt all right of exemption under the Constitution and laws of Alabama, and Plaintiff claims the right of such waiver.

Plaintiff further alleges that in and by the terms of said note, the Defendant agreed to pay all costs of collecting or securing, or attempting to collect or secure this note, including a reasonable attorney's fee, and Plaintiff claims the further and additional sum of \$25.00 as a reasonable attorney's fee in the premises.
