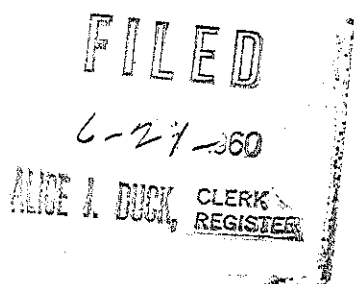

COUNT ONE

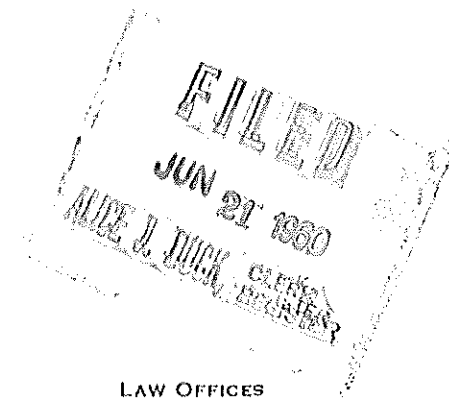


