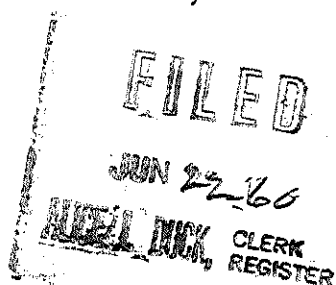
COUNT THREE.

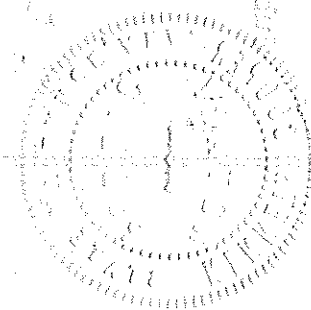
