

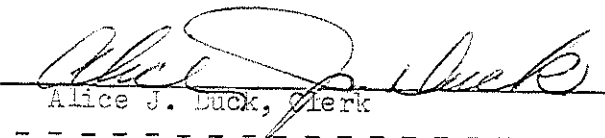

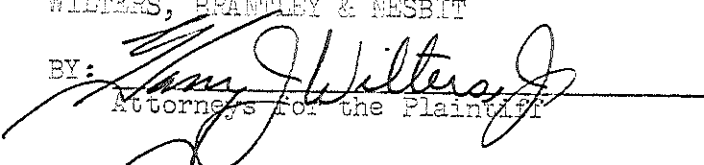

The Plaintiff claims of the Defendant TWO HUNDRED THIRTY-THREE and 93/100 DOLLARS (\$233.93), with interest due on a policy of insurance whereby the Defendant, on to-wit: June 1, 1959, agreed to indemnify the Plaintiff against hospital, medical and surgical expenses resulting from sickness and injories of the Plaintiff, and the Plaintiff avers that on the 25th day of January, 1961, she entered the Providence Hospital, Mobile, Alabama, on the advice of her physican for a posterior colporrhaphy and perineorrhaphy operation, and that this operation was performed and she was discharged from said hospital on the 1st day of February, 1961. That during this period the said policy was in full force and effect and while the Plaintiff has made due and legal proof of her expenses to the Defendant, the said Defendant has failed and refused to pay said sum claimed.
