COUNT III:

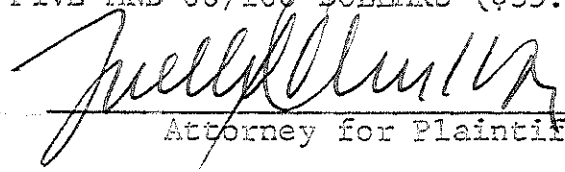
