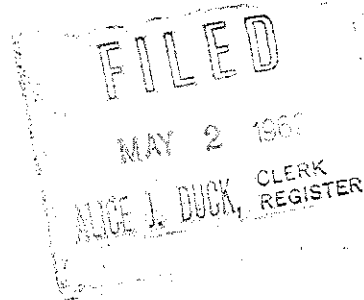
That in and by the terms of said note, defendant waives all rights under the constitution and laws of the State of Alabama as to personal property and plaintiff now claims benefit of this waiver.
