C O M P L A I N T

Count I.

The Plaintiff claims of the Defendant SIX HUNDRED TWO AND 24/100 (\$602.24) DOLLARS due from him by account on the 6th day of November, 1961; which sum of money with the interest thereon is still unpaid.

Count II.

The Plaintiff claims of the Defendant SIX HUNDRED TWO AND 24/100 (\$602.24) DOLLARS due from him for merchandise, goods and chattels sold by the Plaintiff to the Defendant between the 26th day of May, 1961, and the 6th day of November, 1961; which sum of money with the interest thereon is still unpaid.

Count III.

The Plaintiff claims of the Defendant SIX HUNDRED TWO AND 24/100 (\$602.24) DOLLARS due from him on accounts stated between the Plaintiff and the Defendant on, to-wit, the 6th day of November, 1961; which sum of money with the interest thereon is still unpaid.

Count IV.

The Plaintiff claims of the Defendant the sum of TWO THOUSAND NINE HUNDRED THIRTY-SIX AND 65/100 (\$2,936.65) DOLLARS due by promissory note made by him for the original sum of THREE THOUSAND ONE HUNDRED THIRTY-SIX AND 65/100 (\$3,136.65) DOLLARS on the 31st day of May, 1961, and payable in monthly installments of ONE HUNDRED AND NO/100 (\$100.00) DOLLARS per month, commencing on the 20th day of June, 1961, and continuing on the 20th day of each month thereafter until the full amount has been paid; and the Plaintiff alleges that the Defendant defaulted in the payment due

on the 20th day of August, 1961; and the Plaintiff avers that said note provides that upon failure to pay any installment of principal and/or interest when due, the entire principal sum at the option of the holder, shall become due and payable; and said Defendant has only paid the payments maturing June 20th, 1961, and July 20th, 1961; and the Plaintiff avers that in said note and as a part of the consideration thereof, the Defendant has expressly waived his right to claim personal property as exempt to him under the Constitution and laws of the State of Alabama and agreed to pay all costs of collection, thereof, including a reasonable attorney's fee, which reasonable attorney's fee the Plaintiff claims in the sum of FIVE HUNDRED AND NO/100 (\$500.00) DOLLARS.
