



BALDWIN COUNTY COMMISSION

ORDINANCE INDEX

IF USING CONSTITUTIONAL AMENDMENT 809 (FORMERLY ACT 2008-452), THE FOLLOWING APPLIES:

The Baldwin County Commission shall hold two advertised public hearings (advertising in a newspaper of general circulation in the county) on the proposed ordinance, resolution, or regulation or any amendment to ordinances, resolutions, or regulations at regularly scheduled meetings of the Commission.

The Ordinance can be adopted after the 2nd advertised public hearing.

The ordinance shall not take effect until advertisement in a newspaper of general circulation in the county, following its adoption.

IF USING CONSTITUTIONAL AMENDMENT 5.01 (FORMERLY ACT 2006-317), THE FOLLOWING APPLIES:

(*NOTE: The law should be consulted when advertising Ordinances pursuant to this law.)

The Baldwin County Commission shall hold two advertised public hearings (advertising in a newspaper of general circulation in the county) on the proposed ordinance, resolution, or regulation or any amendment to ordinances, resolutions, or regulations at regularly scheduled meetings of the Commission.

The Ordinance can be adopted at the next regularly scheduled meeting of the Commission, following the 2nd advertised public hearing and takes effect immediately.
